### Introduction to Spironucleus muris

Spironucleus muris is a flagellated protozoan belonging to the family Hexamitidae which commonly infects laboratory rodents. S.muris is found primarily in the crypts of the duodenum and pyloric glands and infection does not usually show any clinical signs. However, immune-deficient or weanling mice may exhibit diarrhoea, dehydration, weightloss, rough coat, lethargy, abdominal distention, hunched posture and sometimes death.

S.muris has a direct development and transmission occurs through contact with infective cysts, most commonly through the faecal-oral route through ingestion of infective cysts. As little as one cyst is enough to cause infection.

Prevalence of S.muris in laboratory and wild mouse populations ranges from 4 to 39% and large numbers of S. muris are often an indicator to an underlying disease or infection such as an MHV infection. Additionally, presence of the pinworm may indicate poor biosecurity management. As a result, fast and accurate diagnosis using real-time PCR would greatly aid those keeping and working with laboratory rodents.

## Specificity

The Primerdesign genesig Kit for Spironucleus muris (Spironucleus muris) genomes is designed for the in vitro quantification of Spironucleus muris genomes. The kit is designed to have a broad detection profile. Specifically, the primers represent 100% homology with over 95% of the NCBI database reference sequences available at the time of design.

The dynamics of genetic variation means that new sequence information may become available after the initial design. Primerdesign periodically reviews the detection profiles of our kits and when required releases new versions.

### Kit storage and stability

This kit is stable at room temperature but should be stored at -20°C on arrival. Once the lyophilised components have been resuspended they should not be exposed to temperatures above -20°C for longer than 30 minutes at a time and unnecessary repeated freeze/thawing should be avoided. The kit is stable for six months from the date of resuspension under these circumstances.

If a standard curve dilution series is prepared this can be stored frozen for an extended period. If you see any degradation in this serial dilution a fresh standard curve can be prepared from the positive control.

Primerdesign does not recommend using the kit after the expiry date stated on the pack.

### Suitable sample material

All kinds of sample material suited for PCR amplification can be used. Please ensure the samples are suitable in terms of purity, concentration, and DNA integrity (An internal PCR control is supplied to test for non specific PCR inhibitors). Always run at least one negative control with the samples. To prepare a negative-control, replace the template DNA sample with RNase/DNase free water.

### Dynamic range of test

Under optimal PCR conditions genesig Spironucleus muris detection kits have very high priming efficiencies of >95% and can detect less than 100 copies of target template.

### Principles of the test

#### **Real-time PCR**

A Spironucleus muris specific primer and probe mix is provided and this can be detected through the FAM channel.

The primer and probe mix provided exploits the so-called TaqMan® principle. During PCR amplification, forward and reverse primers hybridize to the Spironucleus muris DNA. A fluorogenic probe is included in the same reaction mixture which consists of a DNA probe labeled with a 5<sup>-</sup>-dye and a 3<sup>-</sup>-quencher. During PCR amplification, the probe is cleaved and the reporter dye and quencher are separated. The resulting increase in fluorescence can be detected on a range of qPCR platforms.

#### **Positive control**

For copy number determination and as a positive control for the PCR set up, the kit contains a positive control template. This can be used to generate a standard curve of Spironucleus muris copy number / Cq value. Alternatively the positive control can be used at a single dilution where full quantitative analysis of the samples is not required. Each time the kit is used, at least one positive control reaction must be included in the run. A positive result indicates that the primers and probes for detecting the target Spironucleus muris gene worked properly in that particular experimental scenario. If a negative result is obtained the test results are invalid and must be repeated. Care should be taken to ensure that the positive control does not contaminate any other kit component which would lead to false-positive results. This can be achieved by handling this component in a Post PCR environment. Care should also be taken to avoid cross-contamination of other samples when adding the positive control to the run. This can be avoided by sealing all other samples and negative control sefore pipetting the positive control into the positive control well.

#### **Negative control**

To validate any positive findings a negative control reaction should be included every time the kit is used. For this reaction the RNase/DNase free water should be used instead of template. A negative result indicates that the reagents have not become contaminated while setting up the run.

#### **Internal DNA extraction control**

When performing DNA extraction, it is often advantageous to have an exogenous source of DNA template that is spiked into the lysis buffer. This control DNA is then co-purified with the sample DNA and can be detected as a positive control for the extraction process. Successful co-purification and qPCR for the control DNA also indicates that PCR inhibitors are not present at a high concentration.

A separate primer and probe mix are supplied with this kit to detect the exogenous DNA using qPCR. The primers are present at PCR limiting concentrations which allows multiplexing with the target sequence primers. Amplification of the control DNA does not interfere with detection of the Spironucleus muris target DNA even when present at low copy number. The Internal control is detected through the VIC channel and gives a Cq value of 28+/-3.

#### Endogenous control

To confirm extraction of a valid biological template, a primer and probe mix is included to detect an endogenous gene. Detection of the endogenous control is through the FAM channel and it is NOT therefore possible to perform a multiplex with the Spironucleus muris primers. A poor endogenous control signal may indicate that the sample did not contain sufficient biological material.

### **Resuspension protocol**

To minimize the risk of contamination with foreign DNA, we recommend that all pipetting be performed in a PCR clean environment. Ideally this would be a designated PCR lab or PCR cabinet. Filter tips are recommended for all pipetting steps.

- 1. Pulse-spin each tube in a centrifuge before opening. This will ensure lyophilised primer and probe mix is in the base of the tube and is not spilt upon opening the tube.
- 2. Resuspend the primer/probe mixes in the RNase/DNase free water supplied, according to the table below:

To ensure complete resuspension, vortex each tube thoroughly.

**3.** Resuspend the internal control template and positive control template in the template preparation buffer supplied, according to the table below: To ensure complete resuspension, vortex each tube thoroughly.

\* This component contains high copy number template and is a VERY significant contamination risk. It must be opened and handled in a separate laboratory environment, away from the other components.

### **DNA** extraction

The internal extraction control DNA can be added either to the DNA lysis/extraction buffer or to the DNA sample once it has been resuspended in lysis buffer.

DO NOT add the internal extraction control DNA directly to the unprocessed biological sample as this will lead to degradation and a loss in signal.

- 1. Add 4µl of the Internal extraction control DNA (BLUE) to each sample in DNA lysis/extraction buffer per sample.
- 2. Complete DNA extraction according to the manufacturers protocols.

## qPCR detection protocol

1. For each DNA sample prepare a reaction mix according to the table below: Include sufficient reactions for positive and negative controls.

2. For each DNA sample prepare an endogenous control reaction according to the table below (Optional):

This control reaction will provide useful information regarding the quality of the biological sample.

- 3. Pipette 15µl of each mix into individual wells according to your qPCR experimental plate set up.
- 4. Prepare sample DNA templates for each of your samples.
- 5. Pipette 5µl of DNA template into each well, according to your experimental plate set up.

For negative control wells use 5 $\mu$ l of RNase/DNase free water. The final volume in each well is 20 $\mu$ l.

6. If a standard curve is included for quantitative analysis, prepare a reaction mix according to the table below:

#### 7. Preparation of standard curve dilution series.

- 1) Pipette 90µl of template preparation buffer into 5 tubes and label 2-6
- 2) Pipette 10µl of Positive Control Template (RED) into tube 2
- 3) Vortex thoroughly
- 4) Change pipette tip and pipette 10µl from tube 2 into tube 3
- 5) Vortex thoroughly





Positive control template (**RED**) is expected to amplify between Cq 16 and 23. Failure to satisfy this quality control criterion is a strong indication that the experiment has been compromised.

\*Where the test sample is positive and the negative control is positive with a Cq > 35, the sample must be reinterpreted based on the relative signal strength of the two results:



If the sample amplifies > 5 Cq earlier than the negative control then the sample should be reinterpreted (via the table above) with the negative control verified as negative.



If the sample amplifies < 5 Cq earlier than the negative control then the positive sample result is invalidated and the result should be determined inconclusive due to test contamination. The test for this sample should be repeated.

#### **Internal PCR control**

The Cq value obtained with the internal control will vary significantly depending on the extraction efficiency, the quantity of DNA added to the PCR reaction and the individual machine settings. Cq values of 28±3 are within the normal range. When amplifying a Spironucleus muris sample with a high genome copy number, the internal extraction control may not produce an amplification plot. This does not invalidate the test and should be interpreted as a positive experimental result.

#### **Endogenous control**

The signal obtained from the endogenous control primer and probe set will vary according to the amount of biological material present in a given sample. An early signal indicates the presence of a good yield of biological material. A late signal suggests that little biological material is present in the sample.
